MiniGrants

Detailed Information

CBTA MiniGrants provide teachers with equipment/materials to help their students do more hands-on science experiments and perform inquiry-based research.

Two MiniGrants will be awarded each academic year for a maximum of \$500 each.

These MiniGrants are available to teachers who have been members of CBTA for at least one year.

The MiniGrant funds must be used to enhance student achievement and classroom instruction.

A teacher may receive only one MiniGrant in a single academic year.

Examples of items the MiniGrants will fund: Balances, colorimeter, egg incubator, equipment for biology field studies, forensic analysis materials, human anatomy and physiology materials, equipment for plant growth/development experiments, micropipettes, microscopes, water quality test kits, or other equipment for student research/inquiry investigations.

Money will be awarded to the recipient's school in the form of a check designated for specific purchase(s) as indicated on the approved application form.

The recipient is required to submit a short article to be printed in the CBTA Newsletter describing and discussing how the equipment/materials were used in their classroom. [See deadlines below.]

The recipient is required to submit a final financial report that includes a copy of the original budget and a copy of the receipt(s) or purchase order(s) for the items ordered. The financial report must include a statement of justification for any deviations from the original budget. The report must be signed by the recipient and principal (or other school financial officer). [See deadlines below.]

If the school and recipient do not use the funds appropriately, then the school and recipient will refund to CBTA the amount of money inappropriately used.

Deadlines

Fall MiniGrant:

- Deadline for submission of application: September 15th
- Deadline for submission of the Financial Report and an article for the CBTA Newsletter: December 15th of that same year

Spring MiniGrant:

- Deadline for submission of application: February 15th
- Deadline for submission of the Financial Report and an article for the CBTA Newsletter: May 15th of that same year
